## project blue *UPDATE*

Funding the annual operating costs of intercollegiate sports teams has become extremely difficult and challenging over the last number of years. Increasingly, teams have come to rely on donations from alumni to enhance opportunities for training and travel.

The Legacy Fund was established as a means to provide an annual source of income for U of T intercollegiate teams. The idea is for each sport to raise an endowment fund, which would generate an annual interest income to supplement the sport's annual expenses. The Badminton team set a goal of a \$73,000 endowment fund, which would provide about \$3,500 of funding annually.

The decision to help was easy. It is not often that you have an opportunity to support a great institution, support an activity you love, get a tax deduction, and know that your contribution will make a very big difference. To date, we have raised \$45,248 including matching amounts towards our target of \$73,000. With your help we can make this goal a reality!
