## project blue UPDATE

Funding the annual operating costs of intercollegiate sports teams has become extremely difficult and challenging over the last number of years. Increasingly, teams have come to rely on donations from alumni to enhance opportunities for training and travel.

The Legacy Fund was established as a means to provide an annual source of income for U of T intercollegiate teams. The idea is for each sport to raise an endowment fund, which would generate an annual interest income to supplement the sport's annual expenses. The Badminton team set a goal of a \$73,000 endowment fund, which would provide about \$3,500 of funding annually.
