Appendix A: Stimuli

Note: each of the first 8 questions has 4 versions, matched for word count, which were varied between subjects; questions 9-16 were the same for all participants. The variants of the first 8 questions are always as follows: (A) ordinary true belief; (B) Skeptical Pressure; (C) Gettier case; (D) false belief.

1A. Albert is in a furniture store with his wife. He is looking at a bright red table in a display. He believes the table is just the shade of red he was looking for. All of the furniture displays in the showroom have been set up by a professional interior decorator who has a real flair for design and an eye for detail. Albert usually likes traditional furniture designs, however the modern design of this particular table appeals to him for some reason. He checks the dimensions and price of the table, and starts to consider buying it. Albert asks his wife, "Do you like this red table?"

1B. Albert is in a furniture store with his wife. He is looking at a bright red table in a display. The displays in the showroom have been set up by a decorator who has a real flair for design. The showroom features a mix of contemporary and modern pieces. Albert likes the way this table looks, and starts to think about buying it. There is in fact normal lighting throughout the showroom. Albert asks his wife, "Do you like this red table?"

1C. Albert is in a furniture store with his wife. He is looking at a bright red table in a display. He believes the table is just the shade of red he was looking for. However, a white table under red lighting would look *exactly* the same to him, and Albert has not checked whether the lighting in this store is currently normal. In fact, this showroom was set up by a very creative lighting consultant who has put different brightly-coloured spotlights over almost all the furniture on display. Most things in the store are lit so that they appear to be different colours, but not the one table Albert is now looking at. The coloured spotlights are set up so that shoppers don't notice them at first. Albert asks his wife, "Do you like this red table?"

1D. Albert is in a furniture store with his wife. What he is looking at seems to be a bright red table, but is in fact a white table with a red spotlight shining on it. He believes the table is just the shade of red he was looking for. This furniture showroom was set up by a very creative lighting consultant who has put different brightly-colored spotlights over almost all the furniture on display, including the white table that Albert is looking at. These colored spotlights are set up so that shoppers don't notice them at first, and Albert himself did not notice that the lighting was unusual. Albert likes the way this table looks. He checks the dimensions and price, and starts to consider buying it. Albert asks his wife, "Do you like this red table?"

Q: Does Albert know whether or not the table is red?

2A. Emma is shopping for jewelry. She goes into a nice-looking store, and spends some time looking at various different displays. She tells the salesperson that she is looking for a simple diamond necklace with a classic design. She always likes to try things on before she makes up her mind about them, and she asks the salesperson to show her quite a wide variety of different items, which he brings out for her one tray at a time. Emma selects a diamond necklace from a tray marked "Diamond Earrings and Pendants". "What a lovely diamond!" she says as she tries it on.

She tells the salesperson that she is looking for a diamond necklace with a classic design. She always likes to try things on before she makes up her mind about them, and the salesperson shows her several options. Emma selects a diamond pendant from a tray marked "Diamond Earrings and

It's Walter, this guy I worked with as a lifeguard last summer." The guards catch up and put Walter into handcuffs right in front of Sarah and her friends.

As Sarah is standing at the entrance of her favorite store, she sees someone being chased by several security guards. "Oh my God!" she exclaims. "I recognize him. Sarah got a good look at Walter there, but would not have been able to tell him apart from his twin brother, if he had a twin brother (he doesn't actually have one).

The switchboard operator of the county hospital confirmed that someone by that name had been admitted with major but not life-threatening injuries following a car crash. Paul grabbed his coat and rushed out to the county hospital. As it turned out, the patient at the county hospital was not Paul's wife but another woman with the same name. In fact, Paul's wife had been kidnapped and was locked in a trailer home on the far side of town.

Q. Does Paul know whether or not his wife is in hospital?

Everyone in the car sees what Brad does, and agrees that there's a very cute baby deer standing very still in the fenced field by the side of the road. The deer doesn't move as they watch it. They slow down to take a good look, and then keep on driving.

At this distance they would not have been able to tell if it had been just a realistic statue rather than a real deer, but it is in fact a real deer, just as they thought. They slow down to take a good look, and then keep on driving.
- 8C. Brad is driving up to his cousin's cottage north of the city with some friends of his. It is late Friday afternoon, and it's sunny and clear out. At one bend in the road Brad points at something on the side of the road. "Hey, look it's a baby deer!" It's more than a two-hour drive to get there, but at least Brad takes a scenic route. At one bend in the road Brad points at something on the side of the road. "Hey, look it's a baby deer!" Everyone in the car sees what Brad does, and agrees that there's a very cute baby deer standing very still in the fenced field by the side of the road. Actually what they were looking at wasn't a deer at all but a very realistic statue put up for decoration by the property owner. There are no deer in the area just now. They slow down to take a good look, and then keep on driving.

Q. Does Brad know whether or not there is a deer in the field by the road?

9. Bob has a friend, Jill, who has driven a Buick for many years. Bob therefore thinks that Jill drives an American car. He is not aware, however, that her Buick has recently been stolen, and he is also not aware that Jill has replaced it with a Pontiac, which is a different kind of American car.

Q. Does Bob know whether or not Jill currently has an American car?

10. Reginald is on his way to meet some friends at Western Mall, but also needs to mail a parcel. He is wondering whether there is a postal outlet in the mall, or whether he should make a separate stop at the post office on the way. He runs into his good friend Max, who has worked at Western Mall as a security guard for the past four years. Reginald asks Max about mail services at Western Mall, and Max tells him (correctly) that there is a postal outlet next to the food court in the mall. Max is a reliable guy, and Reginald trusts him.

Q. Does Reginald know whether or not there is a postal outlet in the mall?

11. Jessica has heard that her boyfriend Justin has been seen with another woman. Recently he has been staying out late a lot, and has become very secretive about his phone calls and text messages. Jessica confronts him one night, and Justin tells her that he has been completely faithful to her. This is a lie – Justin is in fact having an affair – but Jessica desperately wants to stay together with Justin, and fully believes what he tells her.

Q. At the end of the story, does Jessica know whether or not Justin is faithful to her?

12. Everyone who works at the South Wing cafeteria has been wondering what is causing that bad smell in the back stock room. Lisa goes into the stock room one morning to get a new canister of mayonnaise, and as she takes it from a lower shelf, she finds a large dead rat on the shelf. She gets a close look at the body and recognizes immediately that it is a rat.

Q. At the end of the story, does Lisa know whether or not there is a dead rat in the stock room?

13. Principal Winters is wondering out who vandalized the teacher's lounge over the weekend. Rather than reviewing the videotapes from the security cameras, he calls three of his least favorite students down to his office and asks them about the incident. Two of the students loudly deny having done it; one other student – Jack Whitmore – mumbles quietly that he didn't do it. Principal Winters decides that Jack must be the vandal, forgetting that Jack is in general a very shy and quiet teen. Jack is in fact innocent.

Q. Does Principal Winters know whether or not Jack Whitmore vandalized the teachers' lounge?

14. Detective Green is investigating a murder. Watching the surveillance tapes of the parking garage below the apartment building where the murder took place, he realizes that the killer drove away from the scene at 11:30 pm in a red BMW. Physical evidence in the apartment has conclusively established that there are only two possible suspects in the case: the victim's wife and his older son. His wife arrived in town on a flight from Paris at 11:45 pm, and could not have made it to the scene until well after midnight. The victim's older son drives a red BMW. Detective Green concludes that the murder was committed by the victim's older son.

O. Does Detective Green know whether or not the victim's older son committed the murder?

15. Prem and Anurag have been co-workers at the university library for the past six months, and once a week work the same shift at the main circulation desk. They chat about work and current events but don't know each other very well. For example, Prem doesn't know that Anurag has an identical twin brother, Samir. One night, Samir went to a major league hockey game, a game that Prem was watching on TV. When the camera panned over the crowd, Prem saw Samir and thought to himself, "Wow, Anurag is at the game tonight." Anurag was actually at home that night, also watching the game on TV.

Q. Did Prem know whether or not Anurag was at the hockey game?

16. Mike is a serious basketball fan, and was looking forward to seeing his middle-ranked home team play the current league champions. Right before the game he said to a friend, "This visiting team would usually beat us, but it's my birthday today, and that's gotta be good luck. Our guys are going to win."

Q. Does Mike know whether or not the home team will win?
